SP-F: INSTALLATION AND OPERATION

Before You Begin

- For sampling applications, Welker® recommends that the unit be inserted into the center one-third (1/3) of the pipeline in a 1. location where the product is well mixed and will yield an accurate, representative sample.
- 2. For siphoning applications, Welker® recommends that the unit be inserted into the liquids in the pipeline.
- 3. For gas sampling and siphoning applications, Welker® recommends installing the unit in the top of the pipeline. 4.
 - For liquid sampling applications, Welker® recommends installing the unit in the side of the pipeline.
- 5. For liquid sampling applications, locate the unit two to four pipe diameters downstream (2-4D) of an inline static mixer or other flow conditioning system.
- Handle the SP-F Sample Probe with care. 6
- 7. If not included as an optional addition, a valve MUST be installed to the SP-F sample outlet (*Figure 1*) by the customer. This valve will be referred to in this IOM as "customer-supplied outlet valve A."

Installing and Operating the SP-F Sample Probe

Ensure that customer-supplied outlet valve A is closed

The pipeline MUST be depressurized prior to installing and removing the unit.

- 2. Depressurize the pipeline.
 - If the probe tip is beveled, determine the direction of product flow in the pipeline. Install the SP-F Sample Probe with the beveled tip oriented according to company policy and procedure.
- Position an appropriately sized gasket on the mating flange connection. 4.
- 5. Install the SP-F Sample Probe to the mating connection.
- Following a cross-bolting sequence, install bolts and nuts to the flanges. 6.
- 7. Tighten all bolts to the appropriate torque.
- 8. Use appropriately sized tubing to connect from customer-supplied outlet valve A to the customer equipment.
- Pressurize the pipeline and check for leaks. Repair or replace as necessary. 9
- 10. Open customer-supplied outlet valve A to begin operation.

Removing the SP-F Sample Probe

- Close customer-supplied outlet valve A. 1.
- 2. Depressurize the pipeline.
- 3 Disconnect customer equipment from the outlet.
- Remove the SP-F Sample Probe from the pipeline. 4.

SP-F: MAINTENANCE

- Maintenance is necessary if a leak occurs at 1. customer-suppled outlet valve A.
- All maintenance and cleaning of the unit should 2 be performed on a smooth, clean surface.
- 3 Prior to performing maintenance, follow the steps outlined in *Removing the SP-F Sample Probe* to remove the SP-F Sample Probe from the pipeline.




The customer-supplied outlet valve likely contains seals. Welker® recommends that replacement seals should be lightly lubricated before being installed to ease their installation and reduce the risk of damage when positioning them. Wipe excess lubricant from the seals because it could adversely affect analytical instrument results.



For sample-exposed seals. Welker® recommends non-hydrocarbon-based lubricants, such as Krytox®. For non-sample-exposed seals, Welker® recommends either non-hydrocarbon-based lubricants or silicone-based lubricants, such as Molykote® 111.

- Unscrew customer-supplied outlet valve A. 4.
- Debris might have collected in the valve. In addition, the valve O-rings and/or seats might have become worn or 5. damaged. To perform maintenance on customer-supplied outlet valve A, please refer to the manufacturer's Installation, Operation, and Maintenance (IOM) Manual.
- As necessary, carefully clean the probe. 6.
- Reinstall customer-supplied outlet valve A to the SP-F sample outlet (Figure 1). 7.
- Maintenance is now complete. Reinstall the SP-F Sample Probe according to the instructions above. 8.




